Zilla Corporation warrants to the original buyer ("Purchaser") that the Zilla product(s) (the "Product") shall be free from defects in material and workmanship for a period of twenty five (25) years from the earlier of 1) the date the installation of the Product at the Site is substantially complete, or 2) 120 days after the purchase of the Product by the original Buyer of the Product ("Warranty Period").

This Limited Warranty only applies to the Product as installed at the original installation site.

Warranty Exclusions:

THIS LIMITED WARRANTY SHALL NOT COVER: (A) DAMAGE CAUSED BY MISUSE, ABUSE, OR FAILURE TO INSTALL, OPERATE OR MAINTAIN THE PRODUCT IN ACCORDANCE WITH ZILLA CORPORATION'S INSTRUCTIONS; (B) DAMAGE CAUSED BY REPAIR OR MODIFICATION OF THE PRODUCT BY ANY PARTY OTHER THAN AN AUTHORIZED REPRESENTATIVE OF ZILLA CORPORATION, UNLESS ZILLA CORPORATION'S WRITTEN CONSENT WAS OBTAINED PRIOR TO THE REPAIR OR MODIFICATION; (C) DAMAGE CAUSED DURING INSTALLATION OR BY EQUIPMENT OR MATERIALS OTHER THAN THE PRODUCT, INCLUDING EQUIPMENT OR MATERIALS TO WHICH THE PRODUCT IS CONNECTED; (D) DAMAGE DUE TO INSTALLATION IN AN ENVIRONMENT FOR WHICH THE PRODUCT WAS NOT DESIGNED; OR (E) DAMAGE CAUSED BY NUCLEAR INCIDENT, WAR, INVASION, ACTS OF FOREIGN ENEMIES, TERRORISM, VANDALISM, FIRE, FLOODS AND OTHER EVENTS THAT ARE NOT WITHIN ZILLA CORPORATION'S CONTROL, SUCH AS EARTHQUAKES, LIGHTNING, TORNADOES, CYCLONES OR HURRICANES, ICE STORMS AND HAIL STORMS.

This Limited Warranty is transferrable from the Buyer to the owner of the Site, and from the Site owner to subsequent owners of the Site, so long as the transferee agrees to the terms of the Limited Warranty as if it were the Buyer.

This Limited Warranty does not cover material finish, or other considerations that do not substantially affect structural performance.

THIS LIMITED WARRANTY IS IN LIEU OF, AND EXCLUDES, ANY AND ALL EXPRESS AND IMPLIED WARRANTIES THAT MIGHT OTHERWISE APPLY TO THE PRODUCT. Product repaired or replaced by Zilla Corporation under this Warranty shall carry only the remaining portion of the original Warranty. Such repair or replacement shall completely satisfy and discharge all of Zilla Corporation's liability and obligation with respect to matters covered by this limited Warranty.

Manufacturers of other components, such as PV modules, electrical, roofing and or other system elements, may provide written warranties of their own. This Limited Warranty covers Zilla product(s) only, and no other related items.
